Uppsala Cycling Association (*the association*) runs a pool with cargo bikes, trailers, and similar vehicles. The owner of these vehicles can be either the association or other persons. Each vehicle has one or more wardens. Members in the association or other groups associated with the pool can loan vehicles from the pool for a fixed fee under the conditions described herein.

Availability

The association furnishes pool vehicles as-is. Vehicles can normally be booked at most 24 hours at a time. The association reserves the right to limit the number of concurrent reservations per person.

Reservations and payment

Reservations are made through the association's IT system or directly via wardens. Current fees can be found on the association's web site. Making a reservation request implies acceptance of the fee and that the conditions described herein apply to the reservation.

No fee is charged for reservations canceled at least 24 hours prior to pickup.

Pool users shall provide UCF with updated contact information in order to loan pool vehicles. Pool users shall be able to show ID at pickup.

Grounds for denial of use

The association / owner / warden has the right to deny loans

- to users who have debts to the association or who have outstanding obligations to return or repair pool vehicles
- if there is a risk that the vehicle will be damaged, returned late, or that the terms and conditions will not be fulfilled in any other way
- if there is a risk that the vehicle will be used by persons or organizations that work against the association's principle of all people's equal value, or in any way that may damage the organization.

Limitation of responsibility

The association / owner / warden are not responsible for damage (including to persons and property) resulting from use of pool vehicles, even if they occurred due to problems with the vehicle, including problems the association / owner / warden was aware of or should have been aware of. Potential compensation is nonetheless limited to the loan fee.

All transport of passengers in pool vehicles is exclusively at the user's own risk.

Usage

The user agrees to treat the vehicle with care and according to instructions – including staying within load limitations and locking the vehicle to fixed objects when unattended.

The user is responsible for insuring the vehicle if he or she desires.

Vehicles may not be used under the influence of alcohol or other drugs.

Users who loan vehicles from the association are responsible for ensuring that these conditions are followed by all who use the vehicle. It is not allowed to loan vehicles with the primary intention of subsequently loaning them to non-members, or to use a yearly pass (or another contract that enables loans without a per-use fee) to loan vehicles to persons lacking a yearly pass.

Returning vehicles after use

The user agrees to return the vehicle and accessories undamaged to the owner / warden at the agreed time, prior to the expiry of the loan period. The vehicle shall be returned and keys placed according to instructions.

If the vehicle is returned in damaged condition or is damaged beyond repair, the user is responsible within a week to either have the vehicle repaired at a workshop agreed on by the owner, or to replace it with a new equivalent vehicle, respectively.
